Please note as follows: -

1. SACPVP has migrated from an existing financial platform to a new platform which will enable Registered persons to pay their annual and other fees online should they wish to use this option.
2. The process has taken longer than anticipated.
3. Invoices are now being emailed, and all Registered persons will receive an invoice for 2026/2027 during the week of **13 - 17th April 2026**.
4. To re-iterate, the SACPVP Board approved a **3%** increase in the Annual fees.

4. Professional Associated & Single Residential Property Assessor (SRPA)

- Please note that you may request for your Registration Certificate subject to your annual fees for 2026/2207 being paid
- CPD compliance is mandatory. Should you not be CPD compliant then your Registration certificate will be valid for only 1 (one) year
- CPD compliance will ensure that you are issued a Registration Certificate for 5 (five) years

5. Candidate Valuers & Candidate Single Residential Property Assessor (CSRPA)

- For the Ca Val in their 1st and 2nd year of study, upon paying your annual fees, you will be issued with a Registration certificate valid for one year
- For those Ca Val who are in their final year of study and those candidates who have completed their studies you are required to submit your proof of enrolment for the current academic year or email an academic progress
- You will then be issued with a Registration certificate for a period of 5 (five) years.
